As a registered charity, Lewes Old Grammar School can reclaim tax on your donations if you complete a Gift Aid declaration, substantially increasing the value of your gift. If you pay tax at the basic rate, every £1 you give will be worth £1.25 to the School.

If you pay higher rate tax, you can claim the difference between the higher rate of tax and the basic rate of tax on the total gross value of your donation. For example, a donation of £80 would be worth £100 to the School after reclaiming Gift Aid. If you pay tax at 40% you can claim tax relief of 20% of this, or £20, meaning that the total cost to you is just £60.
